Structure of the Governing Body

The school is a community school and it reconstituted in line with statutory guidelines on 1st September 2015.

There are 13 governors appointed:

- 2 elected parent governors
- 1 LA governor
- 1 headteacher
- 1 elected staff governor
- 8 co-opted governors (of which up to 2 could be members of staff).

The term of office of all governors (other than the headteacher) is four years

This instrument of government comes into effect on 1st September 2015.

The Governing Body has established two committees to which it delegates day to day responsibility for the oversight of various aspects of the running of the school: the School Effectiveness Committee and the Resources Committee.
